### **Blue Cross Blue Shield of GA Issues New ID Cards**

BlueCross Blue Shield of Georgia (BCBSGA) is moving to a new operating system and making changes to their website.

As a result, all members will be getting new ID cards with new prefix numbers.

Effective immediately, a provider is no longer able to verify coverage based on patient name and date of birth.

The accurate policy number is required to identify a patient in the new BCBS system.

We are asking our clients to please send a copy of every BCBS patient's ID card. Otherwise we will have to contact your office to obtain the accurate information.

### CMS Revised the Advance Beneficiary Notice of Noncoverage (ABN) to be used in New Year

CMS requires that a new version of the ABN (Advance Beneficiary Notice) form be in use by January 2012. Very minor changes have been made to the form. The only SEP test requiring an ABN is the Pap Test.

The way to differentiate between the new and old ABN form is that the new form has our new SouthEastern Pathology logo in the upper left hand corner and the date 3/11 in the bottom left hand corner. A few things to remember about the ABN:

- Check the appropriate box for Option 1, 2 or 3.
- The form must be signed and dated. The form is invalid if it is not filled out correctly.
- Send the Pink copy with the Pap requisition to the lab. The yellow copy goes with the patient.
- Any old ABN's submitted after January 1, 2012 will be invalid.

The only SEP test requiring an ABN is the Pap Test.
